The president has decided to implement a system of national identity cards to protect against terrorism. A roundtable discussion examines concerns about the cards by looking at separation of powers, checks and balances, the idea of limited government, and privacy issues.	
2 Laboratories of Democracy?: The States and Federalism Today	15
Representative Karl Cushman is exploring the idea of a national criminal code that would supersede state criminal codes. His belief is that the states as “laboratories of democracy” have become ineffective in dealing with crime and that a national code would help unify the country. In his discussions he explores the relationships of the national, state, and local governments to one another.	
3 Whose Privacy? Whose Rights?: Civil Liberties	27
Linda is pregnant by her high school coach and has decided to have an abortion. Her coach and his wife would like to prevent the abortion so that they can adopt the child and raise it themselves. The judge must weigh the interests of the fetus, the mother, and the question of the father’s rights. At issue are privacy rights, the role of the media, government intervention in people’s lives, and the rights of criminals.

Congresswoman Dustman was elected in part due to the strong support of the firefighters' union. Now representatives from that union are asking her to sponsor an amendment that would dramatically change the Americans with Disabilities Act, limiting the rights of persons with disabilities to save the lives of others. The congresswoman must decide whose rights should prevail when rights conflict and issues of equality are at stake.
- 5** Having Our Say: Public Opinion 59
Governor Turner is a novice in politics. He won on a platform of public control, pledging to abide by public opinion in all major policy decisions. Party politicians are frustrated with his reliance on polls and attempt to educate him on the problems associated with letting public opinion guide decision making. How should politicians evaluate public opinion, and what is the nature of public opinion in a democracy?
- 6** Culture in a Country of Immigrants: Political Socialization 73
Pat Richardson and her family are going to dinner at the grandparents' house. There they have a long conversation about the problems facing the country, showing the different opinions and beliefs of three generations, exploring the ways in which Americans are socialized, and highlighting the problems associated with diverse political cultures co-existing in the United States.
- 7** Smoke-Filled and Other Rooms: Interest Groups 89
Senator Keim is thinking about the best way to reform interest groups to prevent the appearance of impropriety. She experiments with this reform by having a meeting with competing interest groups in her office while discussing a bill that she must decide whether to support. The discussion raises questions relating to the nature of representation in a democracy and examines proposals for limiting the potential for corruption associated with interest groups.
- 8** A Dime's Worth of Difference?: Political Parties 103
A BBC report on the primary elections in America explores the problems facing political parties, compares aspects of our system to Britain's, and outlines proposed reforms to improve the U.S. electoral system. The program discusses the weakness of political parties, federalism as it relates to political parties, and the problems of campaign funding in elections. It also explores the strengths of political parties and the roles they play in the U.S. system.

- 9 Selling Candidates: Campaigns and Elections** 117
 Professor David Wiley’s political science class is bored with the lecture, so he initiates a class discussion. The students try to resolve problems associated with the Electoral College, campaign funding, low voter turnout, and other topics related to campaigns and elections.

 Mr. Murtock, a TV station manager, must make some difficult decisions about stories to air on this week’s news magazine. One reporter has filmed a story about a guerilla movement that seems to present America in a bad light, and another reporter has a story about a serial killer that the police do not want aired. The reporters and editors argue the merits of the stories and the proper role of the media in our system.

 Senator Witowski has decided to filibuster a popular bill, arguing that it is not in the best interests of society. His filibuster raises questions about the filibuster, amendments that are not germane, and the role of a representative in a democracy.

 Charles must meet with the three members of his dissertation committee to explain some controversial recommendations he is making about the presidency. He raises questions about the “natural born” clause, candidates who hold dual citizenship, the pardon, and whether the Constitution allows women to become president.

 The president’s campaign included a promise to reform the bureaucracy. Sheldon is the man in charge of doing so, and he must explain to the president the problems he faces and why it is not easy to rid the bureaucracy of inefficiency and waste.

 Jorge Escalante is the newest justice on the United States Supreme Court. His breakfast meeting with colleagues raises issues about judicial review, the role of personal beliefs in judicial decision-making, and political ideology influencing federal judges. Also explored is the appearance of impropriety in the election of state judges.
